


# 2021 Grant Awards: Community Need Increases Due to Pandemic

Every year, Sitka Legacy Foundation solicits grant applications from nonprofit and faith-based organizations, local government and tribal entities for work that benefits residents of Sitka. In 2021, applications increased by 57 percent. This reflects a statewide trend: community needs have grown due to the pandemic and organizations have found it more difficult to raise funds.



SLF received 22 applications for a total of nearly \$62,000 in grant requests in 2021. The Foundation awarded \$25,3000 in funding to 17 organizations.



# **Endowment Growth Update**




Sitka Legacy Foundation has two endowments: the Sitka Legacy Fund for grantmaking, and an endowment that supports our long-term operational needs. As of September 30, Sitka Legacy Fund had a value of \$662,156, representing growth of 11.3 percent in 2021. Our operating endowment value was

\$211,931, representing growth of 25 percent this year.<sup>1</sup>

Endowment growth is generated by contributions from individuals and businesses, matching contributions from Rasmuson Foundation, and an increase in the value of the funds, which are professionally invested by The Alaska Community Foundation (ACF).

Sitka Legacy Foundation is one of 11 local Affiliates of ACF. The chart below shows the value of all Affiliate endowments as of August 2021. Endowment values for the community foundations in Seward and Chilkat Valley reflect significant legacy gifts from local residents. As a result of these gifts, Seward Community Foundation recently reached a milestone of awarding more than \$1 million in local grants since its establishment in 2008.

# Grant Spotlight: Sitka Babies & Books

Sitka Babies and Books encourages Sitka children to become lifelong readers through parent-child programming. This all-volunteer organization provides books, activities, and parent education and support during the first three years of a child's life.

Babies and Books programs are usually offered inperson at Sitka Public Library. The pandemic required wholesale reimagination of their offerings. In 2020, Sitka Legacy Foundation awarded a \$2,000 grant for "Grab-and-Go" bags with books and craft materials to support activities related to the books. Six different free bags were provided to families over the course of the year. The program was so successful that SLF renewed the grant in 2021.

Sitka parent Rebecca Peterman has been participating in Babies and Books since her son was an infant. She explains that the Grab-and-Go bags allowed her child to stay connected to other kids with books during the 2020 lockdowns. "My family initiated several videoconference calls with friends. ### Donor Profile: Bob & Kim Hunter

Bob Hunter first came to Sitka as a medical student in 1976. "I was here in January," he recalls. "It was cold and dark and rainy, and I loved it." He returned with his wife Kim in 1980, and has been practicing medicine in town for more than 40 years.

Both Hunters grew up with family traditions of giving. Kim grew up in a single-parent household with three sisters. "We didn't have much," she recalls, "but we knew we were better off than a lot of people." Her family supported a child overseas through the Christian Giving Fund, and was involved in Girl Scouts. Bob's parents were medical professionals who strongly supported their local library.

The Hunters support many charitable causes in town. When their first child was born, they donated books to the Sitka library in his name. Kim has been active in the Lutheran Church for decades, and has been a Brave



Heart Volunteer since 2013. She worked as a nurse at Fine Arts Camp one summer and has supported Alaska Arts Southeast financially and as a board member. The couple are longtime Raven Radio members and volunteers, and they donated to help build the Community Playground.

The Hunters give to Sitka Legacy Foundation in addition to all of the other local organizations and projects they support. "We give as much as we can to our favorite charities," says Bob, "but our contributions are not a game changer. "Combining our gifts with those from other people through the Foundation really makes a difference." They appreciate matching contributions from Rasmuson Foundation, which make their gifts go farther. They also like SLF's local Advisory Board. "It's great to have a lot of different people with their own loves in the community supporting things that we may not necessarily think of," Bob observes. Finally, he continues, "When we give to other organizations, they need the money and they spend it. Our donations to the Legacy Foundation stay there and build – after we are gone, our money can keep giving to the community that we feel so strongly about because it has been so good to our family."

Advisory Board member Jenilyn Lo moved to Sitka in 2018 to join the team of SEARHC medical providers.

Jenilyn is a nurse anesthetist who maintains privileges at Harborview Hospital in Seattle. This connection gave her a unique perspective at the very beginning of the Covid-19 pandemic. With a firsthand view of how quickly the virus was spreading in Seattle, Jenilyn played a leading role in developing policies at SEARHC to prevent and contain infections in Sitka.

Jenilyn and her husband, also a SEARHC provider, have a daughter who was born at Mount Edgecumbe hospital in 2019. Their family of three enjoys biking, hiking and



boating in Sitka. As the parent of a young child, Jenilyn is especially aware of the shortage of childcare in Sitka. Her primary goal in working with the Legacy Foundation is to help make Sitka more affordable for all generations, from her own toddler to the children, adults and elders that she sees as a community health care provider.

# Give us your thoughts...on giving!

Sitka Legacy Foundation and Sitka Public Library are sparking a community conversation about giving this holiday season. We asked Sitka residents to send us small works of art – poetry, prose, spoken word, video & other visual media – that express their family, cultural and faith-based giving traditions. We are

working with Sitka Public Library to share our community's diverse giving traditions this holiday season. Keep an eye out for giving stories on our Facebook page and website, in local media and at Sitka Public Library in December. Father Ishmael Andrew, the Orthodox Priest at St. Michael's Cathedral in Sitka, writes:

In the Yup'ik culture, we have a tradition to give especially first harvested subsistence food of the season usually to an elder, widowed, or a family that is unable to hunt due to other traditional reasons, for example, if a close family member passed away, the family usually doesn't do any subsistence activity for a certain period of time. I remember bringing the first seal I caught to an elder. I also remember hunting for geese and when I brought home my catch, my parents told me to bring them to a widowed woman. These are just few examples of shared and harvested subsistence food experiences I can recall growing up. These beautiful traditions are still going strong in the Yup'ik communities in the Yukon Kuskokwim area.
