

# Betty Eliason Childcare Center gets first Alaska grant from Freeman Foundation

In 2024, The Alaska Community Foundation received an inquiry from the New York-based Freeman Foundation about funding early childhood education in small, rural, and Indigenous communities in Alaska. The Foundation proposed starting with small grants totaling \$50,000, and asked ACF for guidance on recipients. ACF staff recommended three organizations that received grants from its local Affiliates in 2023, including Betty Eliason Childcare Center.

BECC received \$15,000 to fund books, toys, equipment and supplies for all three of its classrooms, including cribs, strollers, and bikes, kitchen items and snacks, upgrading learning environments for children from 30 families in Sitka.

The Freeman Foundation grant to BECC is a great example of how the Affiliate program leverages philanthropic resources that small Alaska communities might not be able to access independently.



#### Local matchmakers build community

Sitka Legacy Foundation is partnering with local businesses to encourage community giving. Participating business owners pledge to match gifts to our main endowment per quarter. If the match is met, the business chooses a local nonprofit to receive a \$500 grant from SLF.

Thanks to Sitka Work & Rugged Gear for pioneering this program and contributing \$1,500 to match gifts made between October and December 2024. Owners Jessica and Joe Ieremia chose Sitka Golf Association to receive a \$500 grant. "Becoming a Local Matchmaker puts Sitka Work & Rugged Gear in a unique position, one that supports all of Sitka's local non-profits," says SLF Advisory Board member Jessica Ieremia. "We believe a strong community is one where everyone works together for the common good. And as a local matchmaker, we can help make that happen."

Harry Race and White's pharmacies are now matching up to \$1,500 in gifts through June 30.




# 2024 grants

Sitka Legacy Foundation awarded a total of \$26,500 in grants to nine local organizations in 2024, bringing total awards to \$232,678 since 2014.

# SLF is ready to help Sitka in emergencies

When a local disaster like the 2015 Sitka landslide happens, everyone wants to help, right? But what's the best way to do it? Now Sitka Legacy Foundation has a tool to get donations to where they are needed, fast.

Our new Emergency Response Fund for Sitka at The Alaska Community Foundation has been established, and will accept donations in the event of a local disaster. These funds will be distributed to nonprofits and Tribal entities that are prepared to respond. In some cases, recipients will use the funds to maintain their services, such as setting up alternative internet connectivity in the case of an outage. Grantees can also use the disaster fund to provide direct assistance to households, such as food or shelter. The fund is intended to quickly solicit donations and put them to work immediately, not to replace gifts to individual community organizations.

SLF will be contacting nonprofits about the new fund. We hope we don't need to activate it, but if disaster strikes, we will partner with the community to help.


#### Thank you, Northrim Bank!
